1. Surname Column

- . Enter the surname of interest.
- There is a provision for entering a variant of a surname, if required.
- Enter less than obvious variants as a separate entry.
- A surname may have a suffix of [?] if you are unsure.

2. Period Column

- Only one period is entered for each interest.
- The period may be entered in one of these styles:

single century e.g. 19c
range of centuries e.g. 18–19c
later than a date e.g. +1750
before a date e.g. -1852
about a date e.g. c1684
any period e.g. Any

3. Location Column

- Location may be in the form of a parish name, town name, borough name. Area definitions like Dacorum Hundred, West London and East London are less definable and should be avoided.
- You may enter several locations for the same county for a single surname.
- A location defined as "Any" will be assumed to mean all references determined by the Period and County.
- A location may have a suffix of [?].

4. County Column

- Enter the name of the county and also the country name if the county is outside England. Common
 abbreviations are accepted or use the Chapman code if you know it [e.g. Nottingham, Notts, Ntt or
 Glamorgan, Wales, Gla Wls or Victoria, Australia, Vic Aus].
- Only one county reference allowed per entry.
- A county defined as "Any" will be assumed to mean all references determined by Period.

5. Note

The Society uses Chapman Codes for output purposes. Because of the historic nature of most of the interests, old county boundaries are used as a general rule. This is particularly obvious in the London area where the County Code of "Lnd" is restricted to the City of London whilst Bermondsey is in "Sry" and St. Pancras is in "Mdx".
